#### Immerse Lead Artist in Residence Job Description:

Job title:	Immerse Lead Artist in Residence
Reports to:	Schools Project Manager, Imaginate
Fee:	£3,000 (£150 per day) for twenty days' work, plus travel. Additional meetings will be paid at £150 per day/£80 per half day
Hours of work	Two days per week over ten-week period between <b>September -</b> <b>December 2020</b> (one day in school, one day for research and development, plus any planning and communication with Imaginate/school). Artists should be available for a couple of pre- project planning meetings with Imaginate and the school (which can be arranged once project dates are in place).
Location:	Edinburgh city. One day a week in an Edinburgh City school, one day

## **Primary Purpose**

The Immerse Artist in Residence will work with a group of primary school pupils at one of our three Immerse schools. They will develop a theatre and/or dance project including opportunities to share ideas or content with the school community. The theme of the project is open to the interpretation of the artist. Throughout this ten-week period, the lead artist will work with an assistant artist in residence. The assistant artist in residence will be an artist interested in gaining more experience in schools and may not have delivered a residency project before.

working from home/Imaginate office

This Artist in Residence post is part of our wider 3-year Immerse programme, where we are working with six selected schools. Integral to the Immerse programme is the year-round presence of Imaginate and a team of Scottish artists, who will tailor their interventions to each school's needs and build strong relationships with pupils and teachers, creating the foundations for profound and lasting change. The structure of the project also involves a gradual transfer of skills and leadership to teachers, so that by year 3, we hope that teachers will be leading their own creative projects, with support from artists. In the previous year, each of the Immerse schools will have had a visit from Punchdrunk's Lost Lending Library which the whole school participated in, and a 10-week Artist in Residence project working with one year group.

## **KEY TASKS AND REPONSIBILITIES**

This post will develop depending on the skills and artform interests of the selected artist, however the following tasks are a core part of the project:

- Design and deliver a 10-week performance project, working alongside the assistant artist and school.
- Work in school one full day per week with the pupils and school staff, broadening the creative experiences of all involved.
- Create something with the pupils that can be shared with the rest of the school community and parents/carers this could be a short performance, an exhibition or a film, for example.
- Write a project blog post for the Imaginate website.

#### PERSON SPECIFICATION

#### Essential

The successful candidate will:

- Have experience of developing a creative project aimed at primary school aged children.
- Have experience in creating theatre and/or dance performance.
- Have experience of working in a school setting.
- Have a PVG/be willing to become a member of the PVG scheme.
- Live in, or close to, Edinburgh to allow for an early start time in school.

#### Desirable

The successful candidate will:

- Have experience in creating theatre and/or dance performance for young audiences
- Have previously undertaken an artist in residence post.
